

During his talk and also during interaction with audience he emphasized on need of selling of pharmaceutical products by registered pharmacists, role of pharmacists in counseling of patient, drawbacks of online pharmacy and significance of prescription analysis. More than 600 participants attended this inaugural session.


Second webinar in this series was on the topic "Confronting the Realities of Community Pharmacy: The Unspoken Truths & Ways Ahead" by Prof. (Dr.) Ashish Baldi, MRSPT University, Bhatinda, Punjab on 26/06/2021



Prof. Baldi had thoroughly explained the real picture of pharmacy profession including the faulty policies governing the profession, shortage of physician/doctors in the rural India, unethical behavior by some of the pharmacy professionals as well as the encroachment of online pharmacy. In order to tackle the alarming situations Prof. Baldi has suggested the solutions like updating of knowledge by pharmacists for patient counseling and prescription analysis; digitization of pharmacy shops; starting of local digital pharmacy; amendment in the policies and issue of licenses to retail pharmacy shops based on population of any locality. He interacted with the fellow pharmacist, faculty members during his talk.

Prof. Ashish Baldi appreciated the work and initiatives taken by the association.

Third webinar in this series entitled "**Legal Implications for Community Pharmacy Practice in India**" was on 10th July 2021, by Mr. Girish Kulkarni, Associate Vice-President (Sales and Marketing), Intas Pharmceuticals Ltd., Ahmedabad and a medicolegal expert.



Mr. Girish Kulkarni covered important laws governing profession of community pharmacy and mentioned about duties, manner of recommended behavior and services provided by community pharmacists. Further he discussed about telemedicine's and essentials of e-prescription dispensing.
